

Consent for PLASMA IQ

Thank you for choosing Alazzo Med Spa, LLC. This form is exclusively related to plasma sublimation also known as Plasma IQ. Please read this form thoroughly and ask any questions that you may have prior to treatment. This consent will serve for all plasma sublimation treatments performed and does not need to be renewed. Sign only after you feel comfortable enough to get started.

PROCEDURE:

I am consenting to have plasma sublimation performed. A state approved practitioner including a doctor, physician assistant, nurse practitioner or a nurse will do my procedure. Plasma sublimation can assist in reducing the appearance of fine lines and wrinkles, acne scarring, and stretch marks as well as improve the overall texture and appearance of the skin by boosting collagen, adding elasticity and decreasing skin laxity.

PLASMA SUBLIMATION OPERATION:

Plasma Sublimationis a noninvasive and nonsurgical aesthetic procedure that involves radiofrequency/ heat to create microinjuries to the skin. The healing process results in stimulated fibroblasts that tighten the skin and raise the base of the scar, stretch marks, fine line or wrinkle. The procedure will take about an hour. Prior to the procedure a topical Lidocaine will be placed directly at the treatment site. (Allergy to Lidocaine will prevent use of numbing agent) The area to be treated will be cleansed followed by treatment of the designated area. Products will be applied before, during and after the treatment. Please disclose any and all allergies to your provider PRIOR to your treatment. Results cannot be guaranteed. Multiple treatments preformed every 4 weeks are recommended for maximum results. Number of treatments and results are dependent on the area to be treated as well as the severity of the condition requiring correction.

RESTRICTIONS:

- No Accutane use for prior six months
- History of Keloid scar (scar that is raised and grows beyond the wounded area) is contraindicated.
- Wounds, infection, moles, active acne, rosacea or inflammation in the treatment area will be avoided or recommend postponement of treatment.
- 2 weeks between Plasma Sublimation and any other treatments (IPL, LHR, Mico-needling or Hydraderms).
- 4-7 days between Plasma Sublimation and any neurotoxin treatment. (When scabs are no longer present).
- 2 weeks between Plasma Sublimation and any dermal filler treatment.
- History of cold sores may require prophylaxis anti-viral medication
- Vitamin A derivatives (Retin-A, Renova, Differin, OTC products containing retinols, etc) must be discontinued 72 hours prior to therapy.
- · Pregnancy or Lactating is considered safe without use of topical active ingredient. A note from your doctor is

recommended (Please let us know if you are pregnant or trying to become pregnant).

- Use of anticoagulants or other medication that impede coagulation or platelet aggregation will increase risk of bruising (use of non-steroidal
- anti-inflammatory drugs NSAIDs, including aspirin for analgesia or for daily low dose, is permissible.) Blood clotting disorders are contraindicated.
- Pace makers, active implants or metal devices are contraindicated. Any known or suspected systemic or chronic diseases may require a note from your doctor.

STANDARD SIDE EFFECTS:

During the treatment the most frequently reported side effects were pressure, tingling and warmth. After the treatment the most frequently reported side effects were mild discomfort, warmth, tingling, swelling, redness or bruising. Scabs will appear as small circles on the area treated. Some scabs may join together creating a more duffuse scab. DO NOT PICK THE SCABS!!!

UNCOMMON SIDE EFFECTS:

- Delayed Hypersensitivity Allergic Reaction: Allergy not present prior to treatment. Onset days to weeks post treatment.
 Body aches, fever, weakness and redness.
- Post-Inflammatory Hyperpigmentation: Darkening of the treated area. Incidence increases in darker skin types. Use of sunscreen is imperative to

prevent this occurrence. Do not pick scabs off early. This could result in Hypo or Hyperpigmantation.

PRE-TREATMENT INSTRUCTIONS:

Refrain from taking anti-inflammatory medications or drinking alcohol immediately prior to treatment as these actions can thin the blood leading to bruising.

POST-TREATMENT INSTRUCTIONS:

Keep area moist with recommended products. DO NOT apply anything to the treated area unless it is recommended for 4-7 days. Sunscreen can be applied 24 hours after treatment. Sun Protection is imperative for several weeks after treatment. DO NOT REMOVE SCABS EARLY! Once scabs natually come off in 4-7 days and skin has healed, regular skin care routine can resume. Post treatment products will be discussed with you at the time of your procedure. Avoid alcohol-based toners for 10-14 days post treatment.
