

Consent for TOE FUNGUS REMOVAL

Thank you for choosing Alazzo Med Spa, LLC. This form is exclusively related to Nail Fungus Removal. Please read this form thoroughly and ask any questions that you may have prior to treatment. This consent will serve for all Nail Fungus Removal treatments performed and does not need to be renewed. Sign only after you feel comfortable enough to get started.

Procedure: I am consenting to have a laser treatment performed to removal my nail fungus which can occur on my fingers or my toes. A state approved practitioner including a doctor, physician assistant, nurse practitioner or a nurse will do my procedure. Due to the ability of a laser to penetrate the nail it is an effective way to heat up and destroy nail fungus.

Nail Fungus Operation: Removal of nail fungus is a noninvasive and nonsurgical aesthetic procedure that destroys fungus just beneath the nail. The procedure will last anywhere from 5 min to 30min depending on how many nails are being treated. A laser is used to heat up the affected area for a period of time. Results can be seen with just one treatment however multiple treatments are required to obtain your optimal results. Results cannot be guaranteed. Nail fungus as you probably already realize is very stubborn and difficult to get rid of. Treatments are preformed on a monthly basis. Complete destruction of the nail fungus is necessary to prevent regrowth. Since nails grow at a very slow rate this can be a long process requiring multiple treatments, especially if treating the toes.

Restrictions:

- " Wounds, infection or inflammation in the treatment area will be avoided or recommend postponement of treatment.
- " Use of anticoagulants or other medication that impede coagulation or platelet aggregation will increase risk of bruising (use of non-steroidal anti-inflammatory drugs NSAIDs, including aspirin for analgesia or for daily low dose, is permissible.)
- " Any known or suspected systemic or chronic diseases may need a doctors note
- " Sensory loss or dysesthesia in the area to be treated needs to be evaluated

Standard Side Effects: During the treatment the most frequently reported side effects were discomfort, pain, prickling, tingling and warmth. After the treatment the most frequently reported side effects were mild discomfort, or tingling. Blackening of the nail bed can be common but is not necessary as the fungus is heated up and destroyed.

Pre Treatment Instructions: Refrain from taking anti-inflammatory medications or drinking alcohol immediately prior to treatment as these actions can thin the blood leading to bruising.

Post Treatment Instructions: Normal activities can be resumed immediately. Keep feet clean and dry as this can help decrease the spread of fungus.
